1 Respective responsibilities of the body and the auditor

2 External auditor report 2018/19

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, the internal auditor has drawn attention to significant weaknesses in relation to assessment of significant risks and the fixed asset register value not agreeing to the value disclosed in the AGAR annual return. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
